Note:-

1. When D.B.I is not functioning urgent work of that Bench shall be listed before D.B.II and vice versa.

Provided that, if apart from one of the members of the D.B.I or D.B.II, one of the Single Benches is also not available, entire work of that bench shall be listed before the available member.

Provided further that, if apart from one of the members of the D.B.I or D.B.II, more than one of the Single Benches are also not available, only urgent work of those benches shall be listed before the available member.


